IWLA and its affiliated parties, and that the terms of this release are contractual and not a mere recital, and the same shall continue in full force and be applicable to any and all activities the Releasor attends while at the Cburg Mont Co. IWLA facility/property.

Waiver and Release of Liability, Assumption of Risk, and Parental Consent and Indemnity Agreement for Minors Under Age 18

In consideration of my minor child being permitted to participate in any way in Christiansburg Montgomery Co. Chapter of the IWLA activities (hereby referred to as "Cburg Mont Co. IWLA Activities"), I agree to all of the following:

- 1. I understand the nature of Cburg Mont Co. IWLA and the Minor's experience and capabilities and believe the Minor to be qualified to participate in such Activities. I further acknowledge that I and the Minor are aware the activity will be conducted in facilities open to the public during the Activities. I further agree and warrant and will instruct the Minor that if at any time the Minor believe conditions to be unsafe, he/she will immediately discontinue further participation in the Activities.
- 2. I FULLY UNDERSTAND that Cburg Mont Co. IWLA activities involve risks and dangers of SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("Risks"); (b) these Risks and dangers may be caused by the Minor's own actions, or inactions, the actions or inactions of others participating in the Activities, the condition in which the Activities takes place, or the negligence of the Releasee's listed below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time, and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES incurred as a result of the Minor's participation in the Activities.
- 3. I have been informed and understand that certain Activities involve instruction related to shooting technique and may involve physical contact with the participant by an instructor. The bodily areas of contact that may be touched by the instructor include, but are not limited to, the head, hands, arms, hips, back, shoulders, and feet.
- 4. I acknowledge that pictures or video or audio recording of the Activity will be taken periodically. I authorize Cburg Mont Co. IWLA to use any photos, videos, and likeness in all forms and media for advertising, editorial, and all other lawful purposes. I irrevocably authorize Cburg Mont Co. IWLA to edit, alter, exhibit, publish, or distribute such media for purposes of promoting events and any other lawful purpose. I waive my rights to any compensation and release the photographer and Cburg Mont Co. IWLA from all forms of claims and liability related to photo usage. I waive the right to inspect or approve the finished product, including written or electronic copy, wherein my likeness appears.
- 5. I HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE, AND AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS Cburg Mont Co. IWLA, their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessor of premises on which the Activity takes place (each considered one of the Releasees herein) from all liability, claims, demands, losses, or damages on the minor's account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations, and further agree that if, despite this release, I, the Minor, or anyone on the Minor's behalf, makes a claim against any of the Releasees named above, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES FROM ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS LIABILITY, DAMAGE, OR COST ANY MAY INCUR AS THE RESULT OF SUCH CLAIM.
